 Queensland awards night where Quilpie Shire Council in conjunction with Brandon and Associates was awarded a Highly Commended for the new works depot.
- Attending the State Tourism Awards in Brisbane, Cr Mackenzie noted that the Outback Region won five (5) awards.
- Other meetings attended included Darling Downs South West RDA in Toowoomba, a meeting with Mark Mayfield of Santos in Eromanga and a Centenary Celebrations planning meeting in Quilpie.
- Cr Mackenzie attended both the departure from Quilpie and arrival in Oakey of the inaugural Oakey cattle train. Minister for Transport and the Commonwealth Games, Hon Stirling Hinchliffe and Minister for Agriculture and Fisheries and Minister for Rural Economic Development, Hon William (Bill) Byrne were also in attendance at Oakey.
- Travelling to St George on 01 and 02 December with Deputy Mayor, Cr Jenny Hewson and CEO
 Dave Burges a number of meetings were conducted including the South West Regional Road and
 Transport Group (of which Cr Mackenzie is Chair), South West Regional Economic Development
 Group (SWRED), a meeting in relation to rural health training and the South West Local

15.1 (12/16) - Inquiry into the Impacts of Invasive Plants (Weeds)

Queensland Parliament's Agriculture and Environment Committee has invited submissions on their inquiry into the impacts of invasive plants (weeds) and their control in Queensland.

15.2 (12/16) Relocation of Cheepie Railway Building

Subsequent to the November Ordinary Meeting of Council, a final determination on the placement location for the relocated Cheepie Railway Building was discussed. It was agreed the location be in accordance with the recommendation submitted by Mr Kos Siwers.

CHANGE OF ORDER OF PROCEEDINGS

Following verbal receipt of additional information, item 9.1 was tabled for discussion.

9.1 (12/16) - Quilpie Cultural Society, Air Conditioning

Correspondence has been received from the Quilpie Cultural Society requesting an upgrade of the current evaporative air conditioning system. The system is aged and not cooling the building sufficiently for participants to work comfortably during workshops, which at times restricts the usage of the building to the cooler months. Two quotations for the upgrade have been received.

This matter was deferred subject to confirmation on the scope of works required as contained within the quotations.

15.3 (12/16) Meeting Dates

The Chief Executive Officer presented a proposed program of workshops and meetings for 2017 for Council consideration and confirmation.

15.4 (12/16) Draft Tourism Development Strategy

The Draft Tourism Development Strategy developed by 'House of Communications' was presented to Council for discussion and consideration. It was agreed that elected members would thoroughly review the strategy and provide feedback in order that the strategy can be finalised and received by Council in January 2017.

15.5 (12/16) Quilpie Centenary Book

Cr Hewson raised some issues in relation to the contents of the draft Quilpie Centenary Book. A meeting between available Councillors and the Manager Corporate and Community Services will be scheduled to discuss these matters.

15.6 (12/16) Congie Road

Cr Hewson advised that some maintenance work is required on Congie Road. The Chief Executive Officer will follow this matter up.

15.7 (12/16) Galah Street Drainage

Cr Volz advised that there is ponding of water and grass growing in the drain along Galah Street at the Racecourse end. This was noted for actioning.

15.8 (12/16) Quilpie Shire Hall Stage

Cr Volz enquired as to whether fans could be installed above the stage in the Quilpie Shire Hall.

15.9 (12/16) Old Town Bore

Cr Volz suggested that the old town bore could be promoted as an historic feature of the town. An information board and improved appearance (painting etc.) will be further considered.

15.10 (12/16) Pound Paddock

Mayor Mackenzie requested clarification on the historical use of the pound paddock by staff engaged in the rural lands sector.
