1. Introduction

Quilpie Shire Council has recognized the need to develop a documented and planned strategy to increase the economic capacity of the region, thereby improving the economic future and quality of life for residents.

This Economic Development Strategy has been prepared using Council's Community Plan, Corporate Plan and targeted workshops. One of these workshops was a 2 day program facilitated by members of Economic Development Australia under the "Regional and Remote Area Economic Development Training Program".

This strategy will be reviewed each year in conjunction with other Council strategic documents to ensure the various strategies and actions are progressed and funded.

2. Background

2.1 Overview

Quilpie Shire Council covers an area of 67,547 km2, or 3.9 percent of the total area of Queensland. The region has an average daily temperature range of 15.3 degree C to 29.5 degree C and on average receives 340mm of rainfall each year.



2.2 Demography

As at 30 June 2011, the estimated resident population of the region was 1,022 persons, compared with 4,474,098 persons in Queensland.

As at 30 June 2011, 23.5 percent of persons in the region were aged 0 to 14 years, 63.4 percent were aged 15 to 64 years and 13.1 percent were aged 65 years and over.

2.3 Economy

At the time of the 2011 census, the region had 244 persons aged 15 years and over who stated that their total personal income was less than \$400, representing 31.5 percent of all persons aged 15 years and over.

The number of unemployed persons aged 15 years and over in the region in September quarter 2012 was 8. This represents an unemployment rate of 1.1 percent.

At the time of the 2011 census, agriculture, forestry and fishing was the largest industry of employment for usual residents of the region, with 158 persons or 28.9 percent of the employed labour force.

At the time of the 2011 census, managers was the largest occupation group of employment for usual residents in the region, with 174 persons or 32.0 percent of the employed labour force.

Industry and Development

In the 12 months ending 31 December 2012, there were 7 dwelling units in new residential buildings approved in the region, with a total value of \$1.1 million. The total value on non-residential building approvals in Quilpie Shire in the 12 months ending 31 December 2012 was \$0.2 million.

In the 12 months ending 30 June 2012, there were a total of 21 residential dwelling sales in the region. The median sale price was \$97,000.

At the time of the 2011 census, the region had 38 occupied private dwellings with no motor vehicles, or 10.0 percent of all occupied private dwellings.

4. Regional Context

4.1 Office of Economic and Statistical Research¹

ESTIMATED RESIDENT POPULATION

As at 30 June 2011, the estimated resident population of Quilpie Shire Local Government Area (LGA) was 1,022 persons, compared with 4,474,098 persons in Queensland. The population of Quilpie Shire LGA decreased by 4 persons between 30 June 2010 and 2011, which was a population decline rate of 0.4 per cent, compared with 1.1 per cent increase for Queensland.

POPULATION PROJECTIONS

As at 30 June 2031, the population for Quilpie Shire Local Government Area (LGA) is projected to be 979 persons. The population for the region is projected to decrease by an average annual rate of 0.1 per cent over the 20-year period between 2011 and 2031. In comparison, the population for Queensland is projected to increase by an average annual growth rate of 1.8 per cent over the same period.

UNEMPLOYMENT AND LABOUR FORCE

The number of unemployed persons aged 15 years and over (based on a smoothed series) in Quilpie Shire Local Government Area (LGA) in September quarter 2012 was 8. This represented an unemployment rate of 1.1 per cent. In comparison, Queensland had a smoothed unemployment rate of 5.6 per cent.

The unemployment rate in Quilpie Shire Local Government Area (LGA) for the September quarter 2012 was 1.1 per cent, compared with 5.6 per cent in Queensland. Between the December quarter 2010 and the September quarter 2012, the unemployment rate in the region ranged between 0.9 per cent (March quarter 2012) and 1.9 per cent (March quarter 2011).

EMPLOYMENT BY INDUSTRY

At the time of the 2011 Census, Agriculture, Forestry and Fishing was the largest industry of employment for Quilpie Shire Local Government Area (LGA) usual residents, with 158 persons or 28.9 per cent of the employed labour force. Other industries with relatively large numbers of employed persons included Public Administration and Safety (66 persons or 12.1 per cent) and Transport, Postal and Warehousing (49 persons or 9.0 per cent).

A specialisation ratio measures the representation of an industry's share within the Quilpie Shire LGA, relative to Queensland's industry share. The highest specialisation ratios in the region occurred in the industries of Agriculture, Forestry and Fishing (10.65), Public Administration and Safety (1.80) and Transport, Postal and Warehousing (1.71).

EMPLOYMENT BY OCCUPATION

At the time of the 2011 Census, Managers was the largest occupation group of employment for Quilpie Shire Local Government Area (LGA) usual residents, with 174 persons or 32.0 per cent of the employed labour force. Other occupation groups with relatively large numbers of employed persons included Labourers (86 persons or 15.8 per cent) and Machinery operators & drivers (62 persons or 11.4 per cent).

A specialisation ratio measures the representation of an occupation group's share within the Quilpie Shire LGA, relative to Queensland's occupation group share. The highest specialisation ratios in the region occurred in the occupation groups of Managers (2.66) and Machinery operators & drivers (1.56).

Place of work data provides information on people who are employed in a particular geographic area. Persons are counted based on place of employment as opposed to place of usual residence.

At the time of the 2011 Census, Agriculture, Forestry and Fishing was the largest industry of employment for employed persons working in Quilpie Shire Local Government Area (LGA), with 144 persons or 25.7 per cent of the employed labour force. Other industries with relatively large numbers of employed persons included Construction (76 persons or 13.6 per cent) and Public Administration and Safety (70 persons or 12.5 per cent).

A specialisation ratio measures the representation of an industry's share within the Quilpie Shire LGA, relative to Queensland's industry share. The highest specialisation ratios in the region occurred in the industries of Agriculture, Forestry and Fishing (9.39), Mining (2.00) and Public Administration and Safety (1.84).

PLACE OF WORK BY OCCUPATION OF EMPLOYMENT

Place of work data provides information on people who are employed in a particular geographic area. Persons are counted based on place of employment as opposed to place of usual residence.

At the time of the 2011 Census, Managers was the largest occupation group of employment for employed persons working in Quilpie Shire Local Government Area (LGA), with 144 persons or 25.7 per cent of the employed labour force. Other occupation groups with relatively large numbers of employed persons included Technicians & trades workers (95 persons or 16.9 per cent) and Machinery operators & drivers (85 persons or 15.2 per cent).

A specialisation ratio measures the representation of an occupation group's share within the Quilpie Shire LGA, relative to Queensland's occupation group share. The highest specialisation ratios in the region occurred in the occupation groups of Managers (2.11) and Machinery operators & drivers (2.07).

The total value of non-residential building approvals in Quilpie Shire LGA in the 12 months ending 31 December 2012 was \$0.2 million.
