5.2 (05/20) - 2020 Flood Damage Repair Works

Gooyea Road (65), Hell Hole Gorge Road (88) and Pinkenetta Road (36) have been extensively damaged in both the 2019 and the 2020 flood damage events. Contracts to repair the 2019 damage on Gooyea Road (65), Hell Hole Gorge Road (88) and Pinkinetta Road have been awarded. Works are about to commence in the next few weeks.

All three roads have again been badly damaged in the 2020 flood event. As contractors are due on the sites, new invited quotations were called to determine if quick repairs could be economically completed quicker than would otherwise have occurred. The values are more than could be awarded as a variation to the existing contracts
