PURPOSE:

The purpose of this report is for Council to consider the applications received under the latest Exclusion Fence Subsidy Scheme.

BACKGROUND:

As part of their 2020/21 budget Council has allocated \$250,000 towards another exclusion fence subsidy scheme (scheme 4).

DISCUSSION:

Applications have been called from rural property owners in relation to a further exclusion fence subsidy scheme.

Rural property owners were contacted by letter dated 03 August 2020 advising of the scheme and including relevant information and an application form.

Reminders were placed in the August community newsletter.

Applications closed on Friday 28 August 2020.

Thirteen applications were received with two of those providing two alternatives. The application details are summarized in *Table 1* below.

In accordance with the application documentation, the following criteria have been used to assess applications:

- 1. The fencing will promote the production of wool and sheep meat with preference given to properties already carrying sheep.
- 2. The fencing will be in a strategic location to assist with the control and eradication of wild dogs.
- 3. The fencing will assist in increasing sheep and wool production.
- 4. Joint applications between adjoining property owners are considered desirable.

External or boundary fencing only is eligible.

This matter was discussed at a workshop held on 04 September 2020 where the possibility of a strategic cluster fence involving Nickavilla, Maybe, Milroy, Arawee and Moondilla was proposed.

This fence would run roughly north / south with a few east / west doglegs and paralleling a fence to the west. This, together with the Wild Dog Barrier Fence, would provide a large area of protected country that would facilitate future subdividing down to the property level. The properties involved are Nickavilla, Maybe, Milroy, Arawee and Moondilla with the following breakdown:

- 1. Nickavilla 18km (eastern boundary);
- 2. Maybe 24.2km (southern boundary 7.6km and eastern boundary 16.6km);
- 3. Milroy and Arawee 22.7km; and
- 4. Moondilla 8km.

Dan & Louise Hoch and Troy & Amy Kuhn were emailed on Monday 07 September requesting their views on this. Jen and Vin Richardson and Greg Windsor was copied in to the email.

The email included a statement that Council have not committed to further funding but that another similar scheme would be a priority in the next budget if further external funds could not be sourced before then. The partially funded projects would be considered a high priority in any future rounds if the fences were not already constructed.

FINANCIAL:

Council has made a provision of \$250,000 in the 2020/21 budget. Further funding may be available in due course under the QRIDA Rural Economic Development Grant program whereby Council is trying to leverage a further \$250,000 from our allocation. This application is currently under assessment.

On the 24 June 2020, the Queensland Government announced funding for an additional round of the Queensland Feral Pest initiative (QFPI). This future round will allocate \$5 million over 4 years to support construction of cluster fencing. Round 5 is expected to open at any time.
