The benefits of developing a Wild Dog Investment Strategy, Wild Dog Communication and Engagement Strategy, and updating the Pest and Weed Management Plan concurrently ensure each document is aligned, and based on informed stakeholder consultation maximise and value add community input. The Plans will be compatible with current Government strategies, plans and initiatives to ensure maximizing any funding opportunities.
