The purpose of the report is to provide a recommendation to Council to accept the tender for the repair of flood damage for Package T – Trinidad, Regleigh and Springfield Roads.

### **RECOMMENDATION:**

*That Council approve the request by the Toompine Hotel to utilise the Toompine Depot up until 30 April 2021 while undertaking repairs to the Toompine Hotel and all utility charges (power, water etc) are reimbursed to Council at cost.*

### **BACKGROUND:**

The Toompine Hotel has requested permission to utilise Council's Toompine Depot while electrical upgrades are being undertaken on the Toompine Hotel.

### **DISCUSSION:**

Council received the below request on 13/02/2021:

*'Dear Mr Hancock*

*I am emailing today to request the use of the Quilpie Shire Council compound located at the rear of the Toompine Hotel until approximately 30th April 2021.*

*As you may be aware that Toompine Hotel is in much need of repair, including re-wiring which means the power will be disconnected for some time. We are also hoping to upgrade our accommodation facilities during this time.*

*The use of the compound for this short period will benefit us greatly if we could place our temporary workers accommodation units on the land and be able to utilise the council amenities. This additional space will also allow us to prioritise the safety of our workers.*
