ROADS

RMPC

Grading of Shoulders on the Windorah Road (93B) was carried out between 20 and 21 km west of Quilpie due to large ruts at the road edge. The Murweh Shire Council Jetpatcher was used to carry out some seal width reinstatement.



Guide posts and signs maintenance is underway on the Adavale-Blackall Road.

Main Roads TIDS

Gravel has been laid and compacted from 46.32 km to 43.8 km on the Quilpie-Adavale Red Road.

A stabilizer was used to incorporate water into the material. Adavale Plant Hire and B and D Hall have provided equipment to assist.

The first bitumen seal will occur in the week commencing 23 August weather permitting. RSG Group will be carrying out the works.



Main Roads Widening Contract: Quilpie-Charleville Road (REEF).

Works have begun with the first section Chainage 149.5-152.140 km (56-58.6 km from Quilpie). Initial works are clearing and grubbing, formation build up and then formation of the shoulders. A stabilizer will be used to incorporate moisture. Hire equipment from S Bonsey is being used on site as well as Sat Civil for the stabilizer.

Roads to Recovery

The new reseals for 21-22 funded from Roads to Recovery funding have been compiled and tenders form a separate report to this Council meeting. It is planned to deliver these reseal works by 30 September 2021. The projects have been entered into the Federal Government portal.

General Roads

New State Builders have completed the concrete footpaths surrounding Gyrica Gardens as well as a concrete path from Gyrica Gardens to St Finbarr's entrance in Jabiru Street. Council staff will carry out some kerb repairs that do not form part of the contract works.

Distance markers have been placed at Baldy Top Road and at Hell Hole Gorge access roads.

COUNCIL BUILDINGS AND FACILITIES

The new Quilpie house was handed over to Council on 28 June 2021. All works were expected to be completed by 13 August 2021.

A new kitchen has been installed in Council's Kookaburra Court house by Council's tradesman.

Information has been provided to the Queensland National Parks and Wildlife Service offering a recovered toilet block for use at Hell Hole Gorge National Park.

Disabled ramps have been constructed at the Eromanga Natural History Museum.

Work has recommenced on the Knotasuarus Park project.

The screening of the race track commenced on Friday 13 August due to the availability of the Contractor and the current dry weather. This funding and work must be completed otherwise we will lose the funding.

WASTE

The waste transfer station in Quilpie is essentially completed. We are waiting on the delivery of the garbage truck to commence operations. Fencing and signage to reduce access to the larger dump area is in place.

A new putrescent waste pit is under construction in the North West corner of the Quilpie Dump.

Council was issued with a further four Improvement Notices by Workplace Health and Safety Inspectors on 27-28 July 2021. Council staff are dealing with the responses.



Work is underway on the annual State waste survey which is a legislative requirement.

The Depot Clerk carried out an audit of domestic rubbish pickups in the week commencing 26 July 2021. The information has been provided to the finance section.

The Director provided a presentation to the Environmental Health Association Darling Downs and South West Queensland meeting held in Roma on 23 July 2021 regarding Council's improvement works at the Quilpie Dump.

WATER AND SEWERAGE

The annual water and sewerage return (SWIM) was completed. This is a State legislative requirement.

The gang has been working on the water and sewerage requirements for the two new houses.

Recruitment of two plumbers has been underway but not resolved at the time of this report.

The membranes at the Eromanga Reverse Osmosis treatment plant have been replaced.

TOWN SERVICES

Town Services staff have erected fencing near the Quilpie Dump where asbestos has been identified.

Sprinkler heads and locations in the Brolga Street median strips are being replaced to reduce water on the road as well as reduce the impact of vandalism.

Additional toilet cleaning was implemented on 2 August 2021 due to the Covid-19 outbreak in South East Queensland. This included Eromanga and Adavale.

Staff provided a large volume of support work for the Intrust Rugby League event at John Waugh Park.

PLANT/WORKSHOP

The Fleet and Workshop Manager was affected by the south east Queensland lock down and isolation due to Covid-19.

The auto electrician position has been filled.

The garbage truck is overdue for delivery and consideration of costs are being considered against the supplier.

Tenders for plant replacements for 21-22 are being prepared.

3 FINANCIAL DISCUSSION

All funds for submissions approved by QRA have had the required up front funds transferred to QSC.

4 VARIATIONS / SCOPE CHANGES

Several variations have been issued to the various contractors. Some of these were for the preparation of water sources close to the road network, to date we have constructed and utilised the water out of at least 6 of these dams. We have also issued variations to contractors for the rehabilitation of pits once the contractors have completed works out of the pits. Proterra Group have facilitated the inclusion of at Least \$262,000-00 under the R2R funding scheme in these works. This work was included in the contracts that were delivered by Council Day crews plus contractors. Some of this work was conducted on the following roads, Trinidad Road, Ray Road, Adavale Black Road, Old Thargomindah Road, Adavale Charleville Road amongst others.

5 PROGRAM

With the 2020 REPA works coming to an end and the start of the 2021 REPA works, QSC have elected to complete the approved works with a combination of Council Day crew with local contractors. This will ensure that the work gets spread over the full financial year which will ensure that Council crew are also used for these works and are kept busy throughout the year. There has been a slow down of approvals being processed through the various funding agencies, however this can be expected due to the ongoing effects of Covid.

We envisage that all the approvals for 2021 flood damage will be received by October 2021, and with that in mind we would plan to have the physical works completed by June 2022. The next stage of closing out the works have typically taken up to 6 months to complete. This is a process of gathering completion documents and submitting these to the various funding agencies who will do random audits on all this work.

Works on the 2021 program have started with the screening of material on Humeburn Road, unfortunately the screening plant was called away to screen material for RMPC works, therefore the screen will return to Humeburn to complete those works at a future date.

Preparatory works have started on Onion creek and Humeburn Road, with the reconstruction works starting in the 3rd week of August 2021. Seal works on Onion Creek Road are planned for the 3rd week in September 2021 using other funding.

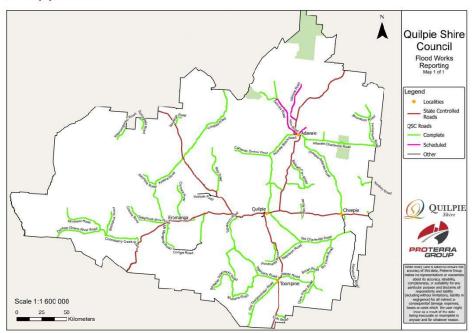
7 Water Issues

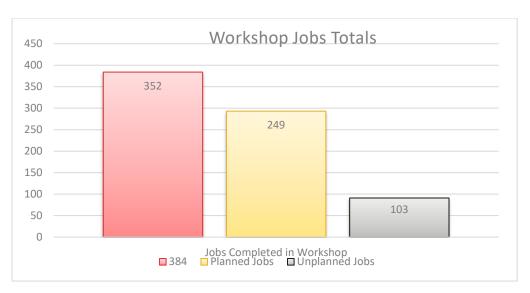

The Quilpie JRL did an amazing job with the juniors and game day program and organisation of the event.

The junior players and school students relished the involvement and guidance of the game development staff and the opportunity to mix it with the QRL players. The Intrust Super Cup did not disappoint with a massive crowd enjoying the game and the post-match celebrations.

LOCALISED MENTAL HEALTH INITIATIVE - JT ACADEMY "BACK TO CHECK IN"

In collaboration with the Country Week Intrust Super Cup, Johnathan Thurston & the JT Academy also visited Quilpie to deliver the "Back to Check In" Program within the Community. The JT Academy Program consisted of 12 events reaching out to as much of the Shire community as possible, including Schools, Seniors, Emergency Services, Emerging Leaders and Businesses. In 2019 the focus of the JT Academy visit to the community was the effect of ongoing drought and whilst this is still a concern for some areas of the shire, this visit also focused on the impact of COVID-19 on the shire community. 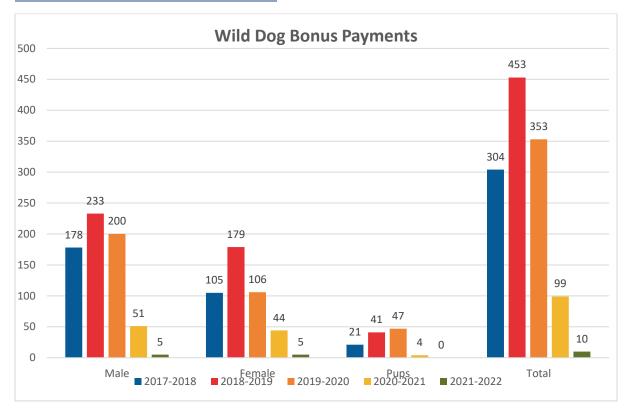

ECONOMIC/BUSINESS DEVELOPMENT

- Workforce development
 - Work continues with SamaLinks to inform her clients about opportunities in Quilpie Shire. Safa is currently working through contacts to identify possible employees to consider relocation to Quilpie Shire. Conversations are ongoing between business and Safa
- ED forum: The Manager attended the face-to-face ED forum in St George. This was a good opportunity to learn about new projects for the region and meet fellow ED officers throughout Darling Downs and South West. The Manager also sat in on the Mayoral meeting as an observer. These forums are a good opportunity talk through initiatives and gain support and or information that may assist Quilpie deliver projects in the future.

TOURISM DEVELOPMENT:

- Events
 - July was a busy month for events with the hosting of Echoes in the Dust and Outback Golf Masters. Both ran well, even with wet weather. Further debrief is scheduled with Queensland Music Trails in August about the event.
 - The VIC staff are currently assisting the Quilpie Golf Open, Quilpie Show and Rodeo and Quilpie Bike Gymkhana & Enduro to promote their events for August and September.
- Visitor numbers were high for July and at the 31st of the month the VIC had recorded 9,073 visits since 1 January 2021, this is just 2,800 short of 2019, which was the highest numbers ever recorded through the Centre. With six months left of the year the Centre staff are hopeful to match this number and more before December. The largest day ever experienced at the Centre was in July with over 300 people visiting the Centre.
- The numbers have flattened out for August and it is anticipated that they will again rise as the September School holidays come closer.
- Toowoomba Caravan and Camping Show: Quilpie participated on the Outback Queensland Tourism stand. Friday was very successful with good numbers; however, numbers over the remainder of weekend were down due to the lockdown in SE Queensland. Many stall holders had to pack up, however the Outback stand team worked through to the Sunday promoting the region.

SWROC PROJECTS:

- EDAC: work continues on the prospectus project with launch imminent before moving into marketing phase.

Tourism: The group are currently working on delivering the events project that will promote signature events in the SW in 2021 and 2022. This includes primarily digital promotion (blogs/facebook etc). This will provide a key messaging strategy for people interested in travelling to the region and what else there is to do. Retaining the 'Be our Guest' tagline and introducing 'Be our plus one!' The campaign is expected to be positive for Quilpie and the Region.
