- (b) Delegate power to the Chief Executive Officer, pursuant to section 257 of the Local Government Act 2009 to negotiate, finalise and execute any and all matters associated with or in relation to this project and contract including without limitation any options and/or variations as per Council's procurement policy.***

RECOMMENDATION

That Council repeal Resolution Number (QSC016-02-23) and replace with:

That Council:

- (a) not award RFQL08 22-23 Flood Restoration Works 2022 Package F and cease the procurement process for this package of works; and
- (b) include ***Wareo Road, Duck Creek Road Portion A and Napoleon Road*** in a new package of works to be released via a Request for Quote through Council's Register of Prequalified Supplier of Mobile Plant and Equipment Wet & Dry Hire (T01) via Vendor Panel.

BACKGROUND

At the Ordinary Meeting on 21 February 2023, Council resolved to award RFQL08 22-23 Flood Restoration Works 2022 Package F – Wareo Road, Duck Creek Road Portion A and Napoleon Road to Tolbra Earthmovers and Haulage Pty Ltd for an amount of \$320,939.55 excluding GST.

Tolbra Earthmovers and Haulage subsequently advised that they wish to decline the offer of RFQL08 22-23 Package F due to separable portion B not being awarded. No contract had been formed between the parties.

RFQL08 22-23 schedule consisted of separable portions for Duck Creek Road, Portion A and Portion B. Portion B consisted of work that relied on QRA funding approval. As stated in the request for quote documents this portion would only be awarded if funding was approved. QRA assessment of Portion B had not been finalised at the time, therefore only Duck Creek Portion A was awarded along with Wareo and Napoleon Roads for this package of works.

WORK SCOPE

The works involved the Reconstruction of Essential Public Assets (REPA), the assets for these works are local roads, to the original condition before storm damage occurred. The roads involved in REPA works for this RFQ include:

- Wareo Road
- Duck Creek Road - Portion A
- Napoleon Road

SCHEDULE OF WORK

A Project Plan for RFQL08 22-23 works had been developed and was scheduled as followed:

- Mobilisation – 7 days post award of works
- Start of works - 9 days post award of works
- Practical Completion - Maximum 90 days after award of works

PROCUREMENT PROCESS

In accordance with Council's Procurement Policy and Part 3 of the *Local Government Regulation 2012*, Council invited seven (7) prequalified suppliers under Contract RFT T01 22-23 Panel of Prequalified Suppliers of Hire of Mobile Plant & Equipment.

At the close of the request process on 13 December 2022, Council received three (3) submissions from the following suppliers:

- APV Contracting Pty Ltd
- Tolbra Earthmovers and Haulage PTY LTD
- SC & KG Bowen

On the 27 January 2023, SC & KG Bowen requested to withdraw their submission.

RFQL08 22-23 was assessed in accordance with the evaluation criteria below:

An assessment of the submissions was undertaken on 8 February 2023 by three (3) officers. The summary of the assessment was as follows:

Council considered this matter at its Ordinary Meeting on 21 February 2023 and resolved as follows:

RESOLUTION NO: (QSC001-02-23)

1. *That Council:*

- (a) *Subject to funding approval and finalisation, award RFQL08 22-23 Flood Restoration Works 2022 Package F – Wareo Road, Duck Creek Road Portion A and Napoleon Road to Tolbra Earthmovers and Haulage Pty Ltd for an amount of \$320,939.55 excluding GST; and*
- (b) *Delegate power to the Chief Executive Officer, pursuant to section 257 of the Local Government Act 2009 to negotiate, finalise and execute any and all matters associated with or in relation to this project and contract including without limitation any options and/or variations as per Council's procurement policy.*

Statement of Reason:

The development of competitive local business and industry.

After Tolbra Earthmovers and Haulage Pty Ltd declined the offer of RFQL08 22-23 Package F, Council needed to consider its options as a contract had not been formed based on Resolution No (QSC001-02-23).

There was one other conforming submission – from APV Contracting Pty Ltd. APV Contracting Pty Ltd was contacted to confirm if they were still interested in the package of works.

Their response was as follows:

Hi Kasey,

As per the request in the below email, APV are willing to proceed with our original tender pricing; however, with these following changes noted and accepted by QSC-APV will be available to complete the package – as there were errors with the original excel spreadsheet on “Wareo Road” we have amended this amount (see attached revised spreadsheet) to show total of \$234,308.61.

Further to the original submission, and upon inspecting the road package area APV request that a variation for extra water, as at the time of the original tender there was sufficient water supply to complete works – however, now water supply is insufficient and will need to be sourced from another waterhole further away – increasing the cost by a further \$62,500.00. This is required for the works on Wareo and Duck Creek Roads.

APV note that Separable portion B – Duck Creek Road has not yet been approved by QRA and therefore is not be apart of the pricing as per the original tender unless advised otherwise.

We look forward to your reply.

It became apparent after their email that the spreadsheet provided by Council in the RFQ documentation which stated that the *totals will auto populate*, was not totalling properly.

Based on this new information about the RFQ documentation, it is recommended to cease the procurement process for RFQL08 22-23 Package F and re-release these works in a future package of works.

Option 1

That Council repeal Resolution Number (QSC016-02-23) and replace with:

That Council:

- (a) not award RFQL08 22-23 Flood Restoration Works 2022 Package F and cease the procurement process for this package of works; and
- (b) include **Wareo Road, Duck Creek Road Portion A and Napoleon Road** in a new package of works to be released via a Request for Quote through Council’s Register of Prequalified Supplier of Mobile Plant and Equipment Wet & Dry Hire (T01) via Vendor Panel.

Option 2

No other option is provided by the author of this report.

Although the other conforming quotation/supplier has provided an updated price based on the schedule they originally submitted with the correct totalling, it is recommended not to award this RFQ due to an error in the RFQ documentation provided by Council. There were also four other pre-qualified suppliers who were invited to quote.

Furthermore, a re-evaluation of the quotation responses with this updated response has not been completed by the evaluation panel.

EXECUTIVE SUMMARY

A Community Assistance Application has been received from Lauran Wendelborn in relation to a two-day horse shoeing school being conducted by Bill Hutton in Quilpie on 11-12 April 2023.

All facets of shoeing will be covered including but not limited to anatomy, the use of tools for shoeing, hot shoeing and hoof x-ray.

The Workshop is limited to 10 participants at a cost of \$3850 per day or \$385 per person per day.

This cost of \$3850 is the day rate regardless of the number of participants

Lauran is seeking:

- 50% subsidy (\$3850) to contribute to the cost of engaging Bill and reducing the cost of each person from \$770 to \$385.
- In-kind support of a fee waiver for the hire of Bulloo Park facilities for the two-day school.

In addition to this, there are a number of high school aged children that are very keen to attend the school, however the cost is a limiting factor for them. Is there an opportunity for:

- Council to advertise and provide one position at the school that is fully funded for a participant under the age of 18. Subsidised amount \$385, non-subsidised amount \$770.

Total amount requested \$4,235 plus in-kind Bulloo Park fee \$315

RECOMMENDATION

1. That Council approves the following:

- (a) 50% subsidy (\$385.00) per participant to contribute to the cost of engaging Bill up to a maximum on 10 participants;
- (b) In-kind support of a fee waiver for the hire of Bulloo Park facilities for the two-day school (Value \$315.00); and

Council to advertise and provide one fully funded position at the school for a participant under the age of 18 (Value \$770.00).

BACKGROUND

Bill Hutton is a highly sought after shoeing instructor and it has taken two years to secure a position to hold a shoeing school in Quilpie. The aim of the project is to provide a skill set which is really lacking in the Quilpie Community. This school has the potential to create additional income if the participants wish to pursue a career as a farrier but also provide a service to the Quilpie, Eromanga and Adavale Communities. Currently most horse owners are traveling to Charleville and beyond to have their horses shod. This school will be of great benefit to the community, not only the Quilpie and Toompine Polocrosse clubs, the Racing Club, the Pony Club, Adavale and Eromanga Gymkhanas but also the people that use horses for stock work and recreation. Having people who are competent in shoeing horses in the Quilpie community will be invaluable.

In addition to the \$385 per day per participant with 10 places available, due to considerable interest Bill is allowing people to also sit in at \$110 each to watch only.

The Quilpie Diggers Race Club have agreed to contribute a small donation towards the school – the amount not yet confirmed.

Letters of support from Horse Sport organisations within the Shire was requested, at the time of producing this report, no letters of support were provided. Letters provided prior to the Council Meeting, these will be provided on the day of the meeting.

Section 194 Grants to community organisations

A local government may give a grant to a community organisation only —

(a) if the local government is satisfied —

(i) the grant will be used for a purpose that is in the public interest; and

(ii) the community organisation meets the criteria stated in the local government's community grants policy; and

(b) in a way that is consistent with the local government's community grants policy.

Section 195 Community grants policy

*A local government must prepare and adopt a policy about local government grants to community organisations (a **community grants policy**), which includes the criteria for a community organisation to be eligible for a grant from the local government.*

This policy covers any request from the community or community organisations outside of established works programs and Council operations. The scope includes financial assistance to community organisations, assistance to businesses and sponsorship requests. Requests for funding will typically be capped at \$2,000 however each request will be considered on a “merit based” approach.

EXECUTIVE SUMMARY

Keeroongooloo Station, owned by Georgina Pastoral Company, has contacted Council requesting consideration for the sealing of Keeroongooloo Station at 6km per year, funded by Georgina Pastoral Company.

RECOMMENDATION

1. That Council support the sealing of Keeroongooloo Road with all maintenance, sealing and bitumen costs to be incurred by Georgina Pastoral Company on a cost recovery basis.

BACKGROUND

Council has carried out flood damage repairs on Keeroongooloo Road in January and February. The road is now in very good condition overall within Quilpie Shire. The total length of the road in Quilpie Shire is 18.7 km. Council recently agreed to install a cattle grid at the Shire's boundary.

The road changes name in Barcoo Shire and is known as Tenham Road and is a further 13.5 km in length.

The Chief Executive Officer of Barcoo Shire advised that the Barcoo Shire has also been contacted.

To seal the road to a width of six metres will likely cost in the order of \$8.50/ square metre plus establishment cost of \$10,000 per trip.

To seal 18.7 km at 6 metres width will cost \$993,700.00 for the seal based on four establishments.

If this is reduced to four metres in width, the cost to seal would be estimated at \$675,800.00.

If Council were to agree to this request, maintenance work would need to be undertaken annually to prepare 6km of road to seal. It is estimated that this maintenance would cost Council \$60,000.00 per seal (6km).

OPTIONS**Option 1 – Recommended**

1. That Council support the sealing of Keeroongooloo Road with all maintenance, sealing and bitumen costs to be incurred by Georgina Pastoral Company on a cost recovery basis.

Option 2

1. That Council decline the request by Georgina Pastoral Company to seal Keeroongooloo Road.

It is estimated that to prepare 6km of road to seal to a 6m length would cost \$60,000. At present, Georgina Pastoral Company has only indicated that the cost to seal and bitumen would be covered. If Council agree cost the cost to prepare the road, future budget provisions would be required.

RISK MANAGEMENT IMPLICATIONS

Medium Risk – Council must consider the ongoing costs associated with sealing the road and potential impacts upon future budgets.
