What is a Wild Dog?

The term wild dog refers collectively to purebred dingoes, dingo hybrids and domestic dogs that have escaped or been deliberately released. Wild Dogs may be pure white, ginger, black and tan or pure black.

Wild Dog Control

Wild dog is a restricted invasive animal under the *Biosecurity Act 2014*.

The Act requires everyone to take all reasonable and practical steps to minimise the risks associated with invasive plants and animals under their control. This is called a general biosecurity obligation (GBO).

Quilpie Shire Council is committed to supporting landholders within the shire to meet the legislative requirements by providing the following services / assistance:

✓ Quilpie Shire WDAC (Wild Dog Advisory Committee)

The Quilpie Shire Wild Dog Advisory Committee was formed in 2005. The purpose of the group is to advise Council on matters relating to wild dogs in an effort to promote uniformity in dog control throughout the Shire and coordination with other shires in the South West Queensland Local Government area.

The Quilpie Shire Wild Dog Advisory Committee membership consists of various representatives from Local Government, Department of Agriculture and Fisheries (Biosecurity Queensland), Wild Dog Barrier Fence, Southern Queensland NRM and Syndicate Leaders from the five Wild Dog Syndicates within Quilpie Shire.

The Quilpie Shire Wild Dog Advisory Committee meets at least twice per year.

✓ Wild Dog Baiting Programs

Quilpie Shire Council and the Quilpie Wild Dog Advisory Committee coordinate two (2) Wild Dog Baiting Programs per year within the Shire – usually around April and September, depending on the weather conditions and wild dog activity. Council supplies subsidised plane hire to approved pilots, subsidised baiting meat and has two (2) licensed 1080 operators that assist the syndicates with the baiting programs. It is a requirement that meat utilised for 1080 baiting is dried out to an acceptable standard prior to injecting 1080.

✓ Wild Dog Levy

A Wild Dog Levy is currently applicable to rural rate payers in categories 11 and 12. This was a recommendation to Council from the Wild Dog Committee and was adopted by Council after consulting with our rural property holders. Over 90% of survey respondents were supportive of the levy. Consequently, Council fully subsidises one 1080 baiting program per year. Council will continue to provide a \$1/kg subsidy on baiting meat on the second baiting program and hotspot baiting. Meat purchased is currently in excess of \$5/kg. Council is hopeful this arrangement will encourage greater participation in baiting programs.

Council strongly encourages **all landholders** within the Quilpie Shire to join their local syndicate and participate in the 1080 Baiting Programs to achieve maximum success in wild dog control within Quilpie Shire.

✓ Wild Dog Control Officers

Quilpie Shire Council employs one (1) full time Wild Dog Control Officer (trapper) who travels throughout the Shire educating and assisting landholders in regard to wild dogs, trapping processes and target baiting hotspots within the Shire. ✓ Wild Dog Control Funding

From time to time Council is also fortunate to access funding opportunities from Federal and State Governments as well as other non-government organisations to assist with wild dog control.

✓ Wild Dog Bonus Payments

In an effort to further support landholders to meet their requirements under the legislation and encourage landholders to practice wild dog control, Quilpie Shire Council provides a wild dog bonus payment, provided that the conditions outlined below are met by the applicant. The wild dog bonus payment is \$50.00 per scalp, caught / destroyed inside or outside the Wild Dog Barrier Fence, within Quilpie Shire (bonus payments may change from time to time at Council's discretion).

PLEASE NOTE - To be eligible to claim the wild dog bonus payment the following conditions must be met:

- Relevant Statutory Declaration form must be completed (available from the Council office) and signed by the landholder of the property on which the dog was destroyed. The Statutory Declaration must be witnessed by a Justice of the Peace.
- GPS points or a map of the property indicating where the dog/s were destroyed must accompany the Statutory Declaration.
- To be eligible to submit an application for a Wild Dog Bonus, the property stated on the application form must participate in a baiting program or practice wild dog control on their property. Properties that do not practice wild dog control will not be eligible to claim the bonus.
- A copy of the claimants drivers licence must accompany the Statutory Declaration.
- The scalps must be delivered to the Council office or sighted by the Wild Dog Control Officer or the Rural Lands Officer.
- A relevant officer of Council (preferably the Pest and Livestock Management Coordinator) must sign the Wild Dog Bonus Application/Statutory Declaration Form, confirming that the scalps have been sighted and match the information on the Statutory Declaration.
- The scalps must be dried or frozen (decomposing or smelling scalps will not be accepted)
- The scalp must be a full scalp – not just the ears and nose
- Scalps must be suitably packaged (not open plastic bags).

The Wild Dog Bonus Application / Statutory Declaration is processed through the Accounts Payable system from the information provided and processed accordingly. Forms must be returned fully completed. Council's payment cycle is thirty (30) days.

Wild Dog Exclusion Fencing

Council fully supports and encourages individual landholders or syndicates constructing exclusion fencing around their properties to control wild dogs. Where funding opportunities are available, Council will assist shire rural landholders by providing an opportunity to apply for a subsidy for the erection of exclusion fencing.
