#### **EXECUTIVE SUMMARY**

The purpose of this report is to provide Council with a recommendation to award RFQL 01 23-24 Mt Margaret and Kyabra Road Sealing for the widening seal of Mt Margaret Road and resealing of Kyabra road in sections damaged by Flood Damage.

#### **RECOMMENDATION**

- 1. That Council:
  - (a) Subject to funding approval and finalisation, award RFQL 01 23-24 Mt Margaret and Kyabra Road Sealing to RPQ Spray Seal Pty Ltd for an amount of \$471,693.38 excluding GST; and
  - (b) Delegate power to the Chief Executive Officer, pursuant to section 257 of the Local Government Act 2009 to negotiate, finalise and execute any and all matters associated with or in relation to this project and contract including without limitation any options and/or variations as per Council's procurement policy.

#### **BACKGROUND**

Quilpie Shire Council (QSC) is undertaking restoration of the sealed and unsealed road networks throughout the Shire that sustained damage following the South Eastern Weather severe weather (20 - 31 March 2021) event March 2021. QSC have applied for funding through the Queensland Reconstruction Authority (QRA) to undertake repairs to essential public assets and have been successful in obtaining funding. The approved sites will be repaired to the pre-event standards in a like for like manner. Council has appointed Proterra group to deliver the Project Management Services for the emergent and restoration works.

#### **Work Scope**

The works involve the Reconstruction of Essential Public Assets (REPA) and Roads to Recovery (R2R), to the original condition before storm damage occurred. The assets for these works are local roads. The roads involved in REPA and R2R works for this RFQ include:

- Mt Margaret Road
- Kyabra Road

#### **Evaluation Process:**

Evaluation Panel (three Officers) were invited to evaluate responses via VendorPanel Multiparty Evaluation on close of the request, 25 July 2023.

All panel members, Project Manager and Procurement Officer attended an evaluation meeting on 31 July 2023.

The final assessment and evaluation scores of the four responses were collated and summary of the evaluation can be seen in the table below:

Council may decide not to accept any responses it receives. The response accepted must be the one deemed most advantageous to Council, it is noted that the lowest price response and/or the highest weighted response may not be the most advantageous.

In accordance with S104 (3) of the Local Government Act 2009, Council must also give consideration to the following sound contracting principles:

- b) Delegate power to the Chief Executive Officer, pursuant to section 257 of the Local Government Act 2009 to negotiate, finalise and execute any and all matters associated with or in relation to this project and contract including without limitation any options and/or variations as per Council's procurement policy.

#### Option 5

#### That Council:

a) resolve not to award RFQL 01 23-24 Mt Margaret and Kyabra Road Sealing.
