

NOTICE OF CONTRACTUAL ARRANGEMENTS WORTH \$200,000 OR MORE FINANCIAL YEAR 2023-2024 (to date 1 May 2024)

In accordance with Section 237 of the *Local Government Regulation 2012*, Council must publish the details of all contractual arrangements with a value of \$200,000 or more (exclusive of GST).

A 'contractual arrangement' is the aggregation of all contracts entered into with a given supplier during a financial year or another period stated in the relevant arrangement, for goods and services of a similar type.

The relevant details must be published on Council's website and displayed in Council's public officer for a period of at least 12 months. The relevant details include:

- (a) the person with whom Council has entered into the contractual arrangement;
- (b) the value of the contractual arrangement;
- (c) the purpose of the contractual arrangement (the particular goods or services to be supplied)
