5.1 T13 25-26 QUILPIE AIRPORT UPGRADE

EXECUTIVE SUMMARY

This report recommends awarding T13 25-26 Quilpie Airport Upgrade to Durack Civil Pty Ltd, for the reconstruction and resurfacing of the Quilpie Airport Main Runway, Taxiway and Apron.

The procurement was conducted through VendorPanel, via open Public Tender. Durack Civil Pty Ltd achieved highest weighted score of 87/100 and demonstrates having best value for money, having regard to price and proven experience.

- (a) Select Durack Civil Pty Ltd as the recommended tenderer for Tender T13 25-26 Quilpie Airport Upgrade;

 - (c) Delegate authority to the Chief Executive Officer (or delegate) to negotiate and confirm provisional sums and other contract particulars, provided that any increase resulting from such negotiations does not exceed 10% of the approved contract value (noting the nature of the contract and the variability associated with the project).
